## INDUSTRY UPDATE . . .

Phone Bills to Rise after PUC Ruling- CC Times Aug 2006 AT&T and three other providers of local telephone service now can raise prices without convincing regulators that their costs have increased, the California PUC recently unanimously ruled.

Business customers are faced with immediate hikes, with phone companies required to give only a 30-day notice. Residential customers will get a respite, in the form of a two-year rate freeze for basic service, but will be subject to price increases after that. Residential customers could also face immediate hikes in the price of caller ID, 900 call blocking and unlisted numbers.

"Existing price caps are no longer necessary in a fiercely competitive market", says Rachelle Chong, the PUC member who sponsored the new set of rules in a market where the traditional providers are facing intense competition from wireless and Internet competitors. "This levels the playing field", Chong says.

The Utility Reform Network (TURN), a consumer advocacy group immediately criticized the new rules for leaving "consumers defenseless against higher phone rates".

The elimination of rate regulation also raises questions about the future of programs that subsidize basic phone services for rural and low-income consumers. Those programs are now funded through charges included in regulated rates in your phone bill. These new rules threaten substantial prices increases for precisely the users who can least afford a price hike. Current rates shift billions of dollars from urban to rural communities. Without those subsidies, the cost of building networks to reach the isolated areas will need to be covered by charging higher prices for local service in those areas.

Two PUC members worried that the panel had acted without fully considering how much the changes would hurt the most vulnerable consumers. "We have to take affirmative steps beyond today's ruling, and reliance on the market to protect those groups" said Dian Grueneich.

Other PUC members, however, argued to "remember that even imperfect competition is superior to costly and burdensome government regulation," and "We are not ending regulation of the industry, just eliminating some that get in the way of competition. "
