### INDUSTRY UPDATE . . .

How Private is Your Internet Information? - PC World 8/06

"You may be surprised to learn that Telecom privacy laws cover only voice, not data", says Ari Schwartz, deputy director for the Center for Democracy and Technology. "We have all kinds of privacy laws that don't make any sense. They're based on how the information is being communicated rather than the type of information." For example, records of your video rentals from Blockbuster are protected under the Video Protection Act of 1988 (remember Robert Bork?), but at&t's videos-on-demand service over the internet are probably not.

at&t's new privacy policy may give you a moment of pause. at&t's new policy only applies to its Yahoo partnership and its video services. However, it says "While your account information may be personal to you, these records constitute business records owned by at&t". It asserts that the company owns the customer's records –email addresses of the people you correspond with, records on the services you use, your online transactions, service charges, the equipment and software you're using, social security number, credit card information including usernames and passwords. Most troubling is that it gives at&t enormous powers to use the information. It says at&t can use "your information" to "investigate, prevent, or take action regarding illegal activities.... or as otherwise required or permitted by law". Some persons are concerned that "permitted by law" might be excessively broad language.

Cable internet's privacy policies are much better. Comcast considers the personally identifiable information contained in our business records to be confidential. And can only disclose a customer's personal information in certain cases – to conduct business related customer services if required by law or legal process.

Fortunately, privacy laws seem to be coming. Hillary Clinton has called for a privacy bill of rights, two congressmen have drafts of bills ready for submission, and the FCC is also reviewing the issue, but for now, if you want to keep your internet and video habits private, opt for cable.
